Editor's Note: Our association is honored to have one of our members serving on a national sub-committee, Gale Mills, External Marketing Committee Co-Chair. During the national meeting Gale attended a meeting and shared the minutes of that meeting with us. They are interesting minutes so take a moment to read. Gale will conclude her service in December of this year.

Debbie Simmons-Gray VP of Public Affairs opened the meeting with past President Judy Breland in attendance.

Debbie referred the meeting to Gale Mills, External Marketing sub-committee co-chair for a report from the five 2010 LW mini-grant winners (see outline provided by Gale at the meeting).

Debbie began the session by asking representatives to promote the Living Well more than a Cookbook by giving to all county commissioners. She also mentioned that several educators had gotten together in one state and made a recipe from the book. As was mentioned in general session, the state needs to move the cookbooks before December 2010 to prevent incurring a hefty storage fee. The suggestion has been made by the national board that each member of NEAFCS sell one case (10 books) Debbie mentioned that in the state of Illinois they put this on their website so it is accessible to everyone.

Chair also discussed the PILD conference and that \$150 scholarship (1 for each state) is available to attend this conference. Deadline to apply for the scholarship is February 1, 2011. The only requirement after receiving the scholarship is to write a short paragraph after returning home Someone suggested that a webinar be done – Debbie thought this was a great idea. Also discussed interacting with the staff of a representative on Capitol Hill. Typically each state meets with other representatives from the other associations (Ag and 4-H) before going to PILD. After attending PILD it was suggested that each NEAFCS member attending send a thank you to their legislator. Dates for PILD are April 3-6, 2011.

Chair also updated us on the fact that NEAFCS have started impact statements again and soon they can be found on our website. There are 5 of them: Financial Management; childhood obesity; Nutrition, health and fitness; Food Safety and The Environment.
