

SE District Report—Danette Russell






The Southeast District has been very busy this year and has 14 members. We have welcomed one new CNEP Area Coordinator, Mamie

Discussion began at the January OEAFCS meeting followed by an adobe connect with a joint meeting of a few members of the membership and public affairs committees to add student members and make a few other minor changes. While researching this it was found that NEAFCS only has one (1) student member and they reside in Arkansas. There was additional discussion about encouraging students to be a member at the state level with encouragement to join National. National has been made aware of our intent and they have no problem with students being members at either the state only or state and national level. A current copy of the Oklahoma Constitution can be found at http://oceafcs.ok-state.edu/history-constitution. Discussion is welcome at board mtg. April 23, 2015.

Proposed changes/additions are highlighted in navy blue; wording that will be deleted will be crossed out; justifications for the changes will be in italics.



OEAFCS Constitution

Section 1: Active Members:

Those eligible for active membership shall be any regularly employed Extension Professional, with a minimum of a bachelor's degree who is actively engaged in Extension work in any area of family and consumer sciences, at the county, area, district or state level. *Justification: Coincide with NEAFCS bylaws wording*. Section 3: Student Members:

- A full time undergraduate or graduate student enrolled in a university, college, or other educational setting, studying family consumer sciences or related field with an interest in Extension Education as a future career who is not currently employed as an Extension Educator. Student members may seek membership in OEAFCS and/or NEAFCS by paying the designated dues amount of \$20 to the state treasurer and one half national if applicable. Membership may be obtained by submitting a student status statement verifying their full time student status.
- 2. Student member shall be granted the following rights and privileges for State only membership: a. They may receive as eligible awards, fellowships, and grants.
 - b. They may serve on subcommittees.
 - c. They may receive the conference registration brochure via e-mail. They shall pay registration fees at the discretion of the VP of Professional Development.
 - d. They shall receive all publications via e-mail upon payment of dues.
 - e. They **shall not** be eligible for elected office, serve as sub-committee chairs, or serve as voting delegates.

Rights and privileges for National Student Membership will follow those outlined in the NEAFCS bylaws. *Justification: Include student members in OEAFCS to encourage networking and employment with Extension.* Section 3 becomes Section 4:

The Oklahoma Association provides equal opportunity to each eligible Extension Professional without regard to race, color, national origin, sex, religion, age, disability or veteran status. gender, age, religion, disability or status as a veteran and is an equal opportunity employer. Justification: Coincide with current OSU disclaimer clause.


