- 2. Under the "Member Resources" tab, click "Dues Renewal."
- 3. Update your profile information in the online renewal form.
- 4. Print the Confirmation Page that comes up after you click submit.
- 5. Send the printed page to your OEAFCS District Director, along with your check for your 2014 dues.

<u>Renewing Member Dues</u> \$125.00(\$100 for national dues, \$25 for state dues) + district dues. As of 11/14, NE District dues are \$125 and NW, SE, SW dues are \$130 for renewing members.

Dual Member Dues (for those who are also OAE4-HA members) \$112.50(\$100 for national dues, \$12.50 for state dues) + district dues.
