

ARTICLE V - *OFFICERS* SECTION I. **Officers.**

The Officers of the Association shall be the President, Vice-President for

Public Affairs, Vice-President for Professional Development, Vice-President for Member Resources, Vice-President for Awards and Recognition, Secretary, Treasurer, President-Elect, Secretary-Elect, Treasurer-Elect, and a Director from each OCES district. The Historian and Chaplain shall be appointed by the President for the President's tenure of office.

The Parliamentarian and Nominating Committee Chair shall be the immediate past president.

SECTION 2. Qualifications.

Officers shall be elected from the active membership of the Association.

The elected officers of Vice-President, Secretary, Treasurer, and Director must be:

Members of the Association for three consecutive years.

Be in attendance at the Annual State Meeting at the time votes are cast for election.

The president shall be selected from any of the past elected officers of Vice-President, Secretary, Treasurer, or Director. The candidate should meet the qualifications of the other officers as above and be an Association member for five years.


